Rev. Steven Russell

Deacon Steve Russell is a life-long resident of the Diocese of Eau Claire. He has served as deacon at Grace - Menomonie and St. Paul's - Hudson. He currently serves on the Commission on Ministry. Steve was ordained to the diaconate by Bishop Jay Lambert in 2016. Steve and his wife, Kobi, have two sons, who are in college. Steve lives in Colfax, WI.

Rev. Benjamin Thomas

Currently I serve as the interim dean at Christ Church Cathedral and am a priest in good standing canonically resident in the diocese. As a member of the Trialogue Task force on structure, I am keenly aware of the critical issues facing the Episcopal Church throughout this region and will bring 15 years of ordained ministry, a doctorate in New Testament and Historical Theology, an MBA, and a great love for this diocese to the standing committee if elected. I have taught numerous subjects at the Bishop Kemper School for Ministry for the last 10 years and have great respect for locally trained clergy.

Rev. Dave Bauer

I was a Wesleyan pastor for 10 years. In 1987, I became a licensed social worker with Sawyer County retiring in 2020 as Juvenile Court Intake Supervisor. I joined the Church of the Ascension in Hayward in 1987, was ordained a deacon in 2014 and a priest in 2015. I have served St. Luke's Springbrook and St. Alban's Spooner since my ordination as a priest. Father Christian Senyoni and I crafted the framework for what would later become the Northern Highlands Benefice in 2018. I serve the Benefice (Grace Rice Lake, Ascension Hayward, St Alban's Spooner, and St. Luke's Springbrook) as interim priest in charge after Mother Meghan Farr's move to Cork, Ireland in July 2022. I was a Deputy to the 2022 General Convention.

Rev. Cn. Kathy Charles

Supply Priest in the Diocese of Eau Claire, also licensed to Supply in Diocese of Minnesota. Involvement in Diocese: Chair of the Commission on Ministry, Executive Council Member, Trialogue Steering Committee, Liaison for Prayer/Discernment Task Force-Trialogue, Chair of the Deputation for General Convention. Served on several committees at General Convention.

Rev. Guy Usher+

Fr. Guy has served four congregations in the Diocese of Eau Claire, and is a life-long member of the diocese. He has served as President of the Standing Committee from 2010-13, and 7/2016 to present, First Alternate Deputy to General Convention 2003, Deputy to General Convention 2012, 2015 (Chair of the Deputation,) 2018 and was elected to serve in 2021.
