# 1. Call to Order

Convention opened by The Very Rev. H. Scott Kirby, Dispatch of Business. The Rt. Rev. Matthew Alan Gunter, Bishop Provisional of the Diocese of Eau Claire, led Convention with Morning Prayer. Following MP, the Rt. Rev. Matthew Alan Gunter called the 94th Annual Convention of the Diocese of Eau Claire to order. Fr. Kirby reminded the Convention that all voting for the 94th Annual will involve documents that have been disseminated before Convention, made available on the Diocesan Website, and discussed in length at the Pre-Convention Hearings. He further reminded Convention that each vote will be announced verbally and presented visually before each vote.

2. <u>Credentials Committee Report</u>: Cn. Aaron Zook, Convention Secretary. 35 clergy are eligible to vote, 19 present. Laity: 45 deputies are allowed and eligible to vote, there are 38 deputies present. A majority of laity and clergy are present. In a Vote by Orders: Clergy needs a vote of 10 or greater, Laity: 20 or greater. Further, 39 votes denotes a super-majority.

# 6. Bishop Gunter's Address:

Bp. Gunter read the Bishop's Address to the Convention, which was met with several comments of appreciation and agreement. Bp. Gunter noted that despite the realities of the pandemic and our polarized society, Christianity has always been a Faith built on "Pilgrimage." He noted that movement toward our next Calling marks nearly every important moment in the story of scripture, but the travel is never isolated; we always walk beside God in these calls and frequently, almost always, walk beside an enormous Cloud of Witnesses that share our pilgrimage. He further noted that we are on a very specific Pilgrimage now, the entire Church, as we move into an unknown future. Though we may have fear and anxiety about where we are going, we find strength and courage in the knowledge that we are surrounded by those pilgrims that share our journey and

by those whose earthly journey has ended. He called us to persevere as we discern the next steps of our lives and ministry together.
